BUSINESS CHALLENGES

"We were investing in a new production facility, and it was time to evolve our existing technologies and Enterprise Resource Planning (ERP) system. A major motivation for change was the fact that Dynamics AX 2012 R2 was no longer supported. There were also serious problems with a lack of functionality in R2 and costly interfaces to external software", explains Dr. Manuela Pfeifer, General Manager of the Production site.

GMP compliance is an important requirement for any pharmaceutical company, and EVER Pharma was unable to continue using its existing Dynamics AX 2012 R2 system as EVER pursued a strategy to further develop and improve GMP and validation standards—particularly at its new production facility in Brüsseler Straße in Jena Lobeda.

Other problems were caused by interfaces with third-party systems. An external weighing and dispensing system—which updated the data with a delay—resulted in an incorrect inventory that had to be updated manually after each production run using the four-eyes principle. In addition, the interface to the warehouse management system (WMS) could only ensure complete traceability of the items with a great deal of additional work.

"Because we had invested heavily in AX, we wanted to stay with AX but resolve our existing problems. Our partner at the time did not have the pharma expertise to support our needs or vision, but we had full confidence AX for Pharma could help us," says Dr. Pfeifer.

The AX for Pharma team recommended upgrading to Dynamics AX 2012 R3 with a fully integrated suite of modules to leverage their investment in Microsoft technologies, eliminate numerous customizations, resolve existing problems, and support their plans for growth.
